5. Public question time

PQT1 Zarinah Adam

The **Mayor, Councillor Hollingsworth** read the following question submitted with notice:

"What are Council's official plans to increase affordable housing to end homelessness? How are councils' official plans to increase housing to end homelessness coordinated with other councils?"

The **Director Community Support** responded as follows:

- Boroondara plays several roles in relation to social housing and homelessness, including advocacy on the provision of social housing, advocacy for funding for homelessness services to provide assertive outreach training and building the capacity of our staff particularly our frontline staff to respond to and support people experiencing homelessness or those at risk of homelessness.
- This approach is captured in Council's homelessness protocol, this protocol ensures people experiencing homelessness are treated appropriately and offered relevant support services.
- We also provide grants to organisations supporting people who are homeless
 or at risk of homelessness. The Boroondara Housing Strategy 2023 also
 acknowledges that increasing the provision of social housing is important to
 address homelessness and whilst Council does not offer financial subsidies or
 assets for the development of social housing that is the responsibility of State
 and Federal Governments. However, Boroondara will continue to advocate to
 both levels of government to increase the available affordable housing stock
 in Boroondara.
- Boroondara undertakes joint advocacy with other Councils on these matters when the opportunities arise.

The **Mayor, Councillor Hollingsworth** informed the meeting that a written response would be provided to Zarinah in due course.

PQT2 Nic Mesic

The **Mayor**, **Councillor Hollingsworth** read the following question submitted with notice:

"What is Council doing to de-stigmatise social housing in our LGA?"

The **Director Community Support** responded as follows:

Increasing supply as well as good design are two key components to reducing
the stigma of social housing as is ensuring that residents in social housing are
well supported. Council supports the delivery of a diverse range of housing
stock including social and affordable housing through existing housing policies
via existing housing policies in the Boroondara Planning Scheme.

- Council does not offer financial subsidies or assets for the development of social housing as this is the responsibility of State and Federal Governments.
- Council has and will continue to advocate to both levels of government to increase and improve affordable and social housing stock in Boroondara on State Government or private land owned and managed by not-for-profit housing associations.
- Council has undertaken strong advocacy on behalf of the community around the Markham Avenue and Bill Street social and affordable housing redevelopment projects. This has included advocacy for a significant uplift in the number of social housing units, above the State government's proposed increase of just 10%. This resulted in an increase of social and affordable housing units from the proposed 62 units to 178 units. In addition, Council advocated for design and amenity as these developments were not in compliance with the big housing build's own standards and local planning scheme expectations improvements in the built form outcome.
- Increases in public social and affordable housing numbers were only achieved through a comprehensive and time and resource intensive advocacy campaign undertaken by Council to improve the overall quality of the projects.

The **Mayor**, **Councillor Hollingsworth** informed the meeting that a written response would be provided to Mr Mesic in due course.

PQT3 Nicholas Bieber

The **Mayor, Councillor Hollingsworth** read the following question submitted with notice:

"Does the Council know how many people are sleeping rough across the LGA and how is Council collecting this information?"

The **Director Community Support** responded as follows:

- The 2021 census counted 320 people as homeless in Boroondara and this
 includes people living in boarding houses, supported accommodation, and
 staying temporarily with other households such as couch surfing as well as
 sleeping rough. The census took place when the Victorian government was
 providing accommodation to Victorians who were sleeping rough so the 2021
 homelessness data may be indicative of long-term homelessness trends in
 Australia.
- However, more recently in 2023, Council received 94 reports related to homelessness this reported multiple reports about a single location where some were sleeping rough. It is estimated that of the 94 reports to Council there were 68 unique cases of primary homelessness affecting single people couples and families in the municipality.
- The City of Boroondara has a homelessness protocol which was developed in 2009 in partnership with the Salvation Army, our regional homelessness support service. Council receives reports of homelessness namely rough sleeping from residents, businesses and under this protocol facilitates referrals to outreach services.

 As per the homelessness protocol de-identified information is collected by reports of homelessness. Case coordination activities are undertaken with relevant services, this is used to compile and maintain Council statistics and information on the incidence of primary homelessness in Boroondara.

The **Mayor**, **Councillor Hollingsworth** informed the meeting that a written response would be provided to Mr Bieber in due course.

The **Mayor, Councillor Hollingsworth** read the following question submitted with notice:

"Why has Council and the MBS not taken appropriate available action under the Building Act 1993 to enforce the Building order on the adjoining property?"

The **Director Urban Living** responded as follows:

 The matter is currently being progressed with Court proceedings against the owners for non-compliance with the building order requiring works to be carried out. Prosecution in these types of cases in the Magistrates Court is a last resort which is pursued when all other avenues to achieve compliance have been exhausted.

"Regarding the outcomes of Gardiners Creek No Glyphosate Trial, if chemicals are not included in this specific trial, why is there a budget for chemicals in this specific report?"

The **Director Places and Spaces** responded as follows:

• Council undertakes weed management to maintain the presentation of our public spaces, to ensure that surfaces are safe for people to use and to manage and protect our biodiversity. We use a range of different methods to manage weeds which includes mechanical methods and herbicides. There are a number of different herbicides used which target different types of weeds. These herbicides have different active ingredients, only those containing glyphosate were eliminated from use during the trial period. The budget for chemicals relates to the other herbicides that were used.

The **Mayor**, **Councillor Hollingsworth** informed the meeting that a written response would be provided to Ms Tobin in due course.

"The \$9,000 figure for goats in the No Glyphosate Trial needs to be checked. Does this include the Balwyn (goat) site which was not part of the Gardiners Creek trail?"

 The \$9,000 is the cost for the use of goats for the period they were used within the trial area along Gardiners creek between Warrigal and Glenferrie Roads.

7.1 Revised Instrument of Delegation - Council to Council Staff

Purpose

This report seeks Council's review and approval of the Instrument of Delegation to Members of Council Staff (the Instrument) under the *Local Government Act* 2020 (the Act).

Background

Council is empowered by section 11 of the Act to delegate its powers, duties or functions with some strategic exemptions (such as the setting of rates, borrowing funds, adopting a planning scheme amendment and adopting a budget).

Delegations are needed to facilitate the effective function of Council, enabling day-to-day decisions to be made about routine administrative and operational matters.

Key Issues

The Instrument includes any legislative amendments and changes to staff titles and delegates since the last Instrument was adopted by Council in December 2023.

Next Steps

The Instrument will be circulated to officers following adoption so that the organisation is aware of any changes to delegations.

The Instrument is reviewed by officers and presented to Council biannually, to ensure any new legislative or staff changes are captured. Officers expect another report to be presented to Council in mid-2024.

7.2 Instrument of Appointment and Authorisation - Environment Protection Act 2017 & Planning and Environment Act 1987

Purpose

This report brings to two Instruments of Appointment and Authorisation under the *Environment Protection Act 2017* and the *Planning and Environment Act 1987* to consider executing. These Instruments propose to appoint and authorise staff in the Urban Living Directorate to regulate:

- On-site wastewater management systems not exceeding 5000 litres on any day;
 and
- Noise from construction, demolition and removal of residential premises.

Background

Maddocks recommend that officers enforcing the *Planning and Environment Act* 1987 be authorised by Council resolution and for relevant Instruments of Appointment and Authorisation to be refreshed regularly.

To ensure that the Instruments are up to date and account for staffing changes within the organisation, officers undertake a review of the Instruments bi-annually. The last review of this Instrument occurred in December 2023. Council last adopted an Instrument of Appointment and Authorisation under the *Environment Protection Act 2017* in February 2024.

There were no legislative changes relevant in the current review requiring change to the Instruments. The changes to the Instruments relate to staffing arrangements in the Urban Living Directorate.

Key Issues

Officers present a refreshed Instrument of Appointment and Authorisation under the *Environment Protection Act 2017* (**Attachment 1**), and an Instrument of Appointment and Authorisation under the *Planning and Environment Act 1987* (**Attachment 2**) for adoption.

Next Steps

The Instruments will be refreshed as needed to ensure any staffing changes within the Urban Living Directorate are captured.

7.4 Contract No 2023/231 Michael Tuck Stand Structural Rectification Works

Purpose

This report seeks Council endorsement for the award of Contract No. 2023/233, Michael Tuck Stand Structural Rectification Works to the recommended tenderer Stokes Rousseau Pty Ltd for the sum of \$1,226,734.65 excluding GST.

Background

Council is seeking to redevelop the Michael Tuck Stand, which is located at Glenferrie Oval - 34 Linda Cres, Hawthorn. The Michael Tuck Stand was built on Council land in 1938 as the flagship facility for the Hawthorn Football Club, which played at Glenferrie Oval from 1903 to 1973. The club retained its presence from 1973 until 2006 as an administrative and training base, before relocating permanently to Waverley Stadium. The stand is an underutilised heritage asset (Victorian Heritage Register H0890) owned by the City of Boroondara.

The building has an internal ground floor area of 1,021m², a first-floor area of 471m² and an additional 950m² of grandstand seating. The building has been deteriorating for some time and needs major renovation. Council has allocated \$27.98 million in its Long-Term Financial Strategy (LTFS) towards the revitalisation of the Michael Tuck Stand and Glenferrie Oval. Costs will be staged across multiple financial years.

Stage 1 of the redevelopment project has recently been completed, involving internal strip-out and non-structural demolition. The primary objective of Stage 1 was to uncover latent conditions crucial for upcoming design and construction activities. Throughout Stage 1, various structural issues were identified, some of which were classified as high or very high risk by structural engineers, requiring urgent rectification.

The purpose of the Structural Rectification works, as identified in this contract report, is to promptly address these high-risk or very high-risk structural issues. The rectification works encompass various areas of the building, with the main scope including:

- Demolish and replace existing damaged concrete slab and brick wall to the south-west of building
- Repairs to masonry retaining walls including tanking
- Repairs to spalling concrete beams, columns and slabs,
- Waterproofing membrane to grandstand slab including repairs of joints.
- Replacing/repairing lintels

In accordance with Council's Procurement Policy 2021-25, Council invited public tenders from suitably qualified organisations, and a recommendation to award Contract No. 2023/231 Michael Tuck Stand Structural Rectification Works is presented for Council's consideration.

The works are expected to commence July 20204 and to be complete by December 2024.

The foreshadowed budget for the financial year of 2024-25 is \$1.75 million, which is sufficient to fund the award of this contract.

The total cost of this contract is \$1,226,734.65 excluding GST.

Key Issues

The community was invited to provide feedback on the draft Vision and Design Brief to revitalise the Tuck Stand and Glenferrie Oval, from 14 August to 11 September 2023. Following community consultation, the Vision and Design Brief was updated and subsequently endorsed by Council in December 2024. The Vision and Design Brief document serves as a roadmap for Council to unlock the potential and bring new life into this unique heritage asset, incorporating a staged approach that includes Structural Rectification works.

Careful consideration has been given to the building's heritage significance. Heritage Victoria has granted a permit for the proposed structural rectification works. The recommended tenderer is registered with Victoria Heritage Services and has experience with the heritage projects.

Consideration has also been given to the impact of construction works to the amenity of the neighbouring residents. A site establishment plan has been prepared which outlines the following:

Off-street contractor designated parking area;

- Designated on-site area for storage of materials, contractor office and amenities set up; and
- Appropriate hoarding will be securely installed to ensure community safety during the works.

Next Steps

Upon award of the contract, Council will oversee the delivery of the building works for Contract No. 2023/231, Michael Tuck Stand Structural Rectification Works.

7.5 February 2024 Monthly Financial Report

<u>Purpose</u>

The purpose of this report is to provide Council the Monthly Financial Report for February 2024. The Monthly Financial Report is designed to identify and explain major variances at an organisational level and is provided in **Attachment 1**.

Background

The year to date annual budget referred to in this report reflects the 2023-24 Amended Budget, approved by Council on 23 October 2023 which includes the carry forward funding for 2022-23 priority projects and capital works forward commitments.

Key Issues

Year to date actuals vs. 2023-24 Amended Budget

Council's favourable operating result against year to date budget of \$96.40 million is \$12.66 million or 15% above the 2023-24 Amended Budget of \$83.74 million primarily due to a number of factors which are outlined in **Section 2** of **Attachment 1** - **Financial Overview**.

Capital works actual expenditure of \$33.25 million which is \$7.01 million below year to date budget phasing of \$40.26 million. Priority projects expenditure of \$12.94 million is \$5.70 million below year to date budget of \$18.64 million.

Council's Balance Sheet and cash position are sound and depict a satisfactory result. At the end of January Council's cash position stood at \$188.54 million or \$24.29 million above year to date budget.

7.3 Proposal to take title to land remaining unsold from a previously discontinued road - Rear 34 to 60 First Avenue and 2 to 30 Maitland Avenue, Kew

<u>Purpose</u>

This report is to consider a proposal for Council to take title to the land remaining unsold from a previously discontinued road at the rear of 34 to 60 First Avenue and 2 to 30 Maitland Avenue, Kew, shown in **Attachment 2** as Lots 2, 3, 5, 6, 9, 10, 11, 12, 13, 14, 17 and 18 ("the Land").

Background

Council discontinued the 3.05m wide road at the rear of 34 to 60 First Avenue and 2 to 30 Maitland Avenue, Kew in two separate discontinuances in July 1999 and May 2000. The discontinued road is shown hatched in **Attachment 1.**

None of the land from the discontinued road was sold at that time.

In 2011 Council canvassed the possible sale of the remaining unsold Land. As a result of these negotiations, four (4) lots were sold.

In 2022, Council again canvassed the possible sale of the remaining unsold lots, in accordance with Council's current policy. These recent negotiations have resulted in none of the property owners expressing an interest in acquiring any land.

At this time, property owners were informed of Council's intention to take title to any unsold Land, consistent with the current Discontinuance of Roads and Reserves Policy 2022. Further, property owners have been informed that as a result of this action, they would be precluded from pursuing an application at Land Use Victoria for title to the Land via adverse possession.

It is considered that owners have been provided with ample opportunity to decide over the course of negotiations whether or not to acquire the Land (or alternatively pursue an application to Land Use Victoria for title via adverse possession) and that Council should now proceed to uphold its intention to take title to the unsold Land.

Key Issues

- The Land is in the name of the original subdivider.
- The Land has been enclosed within the adjoining properties for in excess of 15 years.
- Following consultation and negotiations with the adjoining property owners on three occasions over several years, 12 parcels of Land remain unsold.
- Council's current policy provides that Council will take title to all unsold discontinued sections of road.
- Although it was not Council's policy to take title to unsold land when the road was originally discontinued, property owners were informed of this proposed action, and the consequence of this action, during the course of recent negotiations in 2022.
- Future sales of Land will be at market value.

- 2. Authorise the Chief Executive Officer, or such other officer as the Chief Executive Officer approves, to sign all necessary documentation associated with Council taking title to the unsold Land, including making application to Land Use Victoria for title to the unsold Land.
- 3. Authorise the Chief Executive Officer, or such other officer as the Chief Executive Officer approves, to commence the sale process under section 114 of the *Local Government Act 2020* for any unsold lots.

7.6 Outcomes of Gardiners Creek No Glyphosate Trial

Purpose

The purpose of this report is to present the outcomes of the Gardiners Creek No Glyphosate Trial which ran from the beginning of December 2022 to the end of November 2023.

Background

At the Council meeting on 22 August 2022 Council carried the following motion:

- Resolve to continue to implement a weed management approach that enhances the appearance of public spaces and biodiversity, including a variety of approaches and seeks to minimise the use of herbicides and any potential negative impacts on human health and the environment, including
 - a. Ceasing the use of glyphosate for a trial period of 12 months along the Gardiners Creek corridor (adjoining open space), commencing at the start of Summer 2022 and concluding at end of Spring 2023.
 - b. Ceasing the use of Fluroxypyr within a specific trial site (Winton Rd Reserve and behind properties along Gardiners Creek from Winton Rd to Solway St, Ashburton), commencing at the start of Summer 2022 and concluding at end of Spring 2023.
- 2. Publish on our website the weed control site methods and practices, and the dates and locations for yearly weed management activities.
- 3. Bring a report on the findings of the 12-month trial to a future Services Delegated Committee.

Key Issues

- The Gardiners Creek No Glyphosate Trial finished at the end of November 2023, although the practices have continued into 2024.
- Overall, the asset condition rating of the sites in the trial area showed a small decrease in site condition.
- The total volume of herbicide used at biodiversity sites across the trial area decreased by 27,475.15ml (from 36,355.75ml to 8,880.6ml).
- The total number of hours spent on the management of biodiversity sites across the Gardiners Creek trial area increased by 348.5 (from 2,719.5 hours to 3,068 hours).
- Based on the increased hours and reduced chemicals spent in maintaining the biodiversity sites across trial area, an extra cost of \$29,280 has been identified for the trial period.
- Sections of the trial area included goat grazing at a cost of \$9,000 over the trial period (included in the amount above).

Next Steps

Continue the trial through to the end of Spring 2024 to enable more data collection.

- 3. Receive a further report on the findings of the two-year trial period to a future Services Delegated Committee.

7.7 Draft Procurement Policy 2024

<u>Purpose</u>

To present the draft Procurement Policy 2024 ("Policy") to Council for adoption. The amended Policy is attached to this report.

<u>Backgroun</u>d

The adoption of the current Procurement Policy in December 2021 and changes to the procurement operational model in early 2022, prompted a review of the policy and operational procedures. The aim of the review has been to ensure Council's procurement function is effective, efficient and is an enabler to achieving Best Value.

Key Issues

The review identified opportunities to improve procurement and contract management processes and several amendments are proposed accordingly.

Policy

Removal of supporting guidelines

The current Procurement Policy has five supporting guidelines. Consultation with stakeholders has indicated the guidelines are confusing and are not being utilised.

All critical information from these guidelines has been merged into the Policy and all operational requirements will be made available in supporting internal Procurement and Contract Management Procedures (currently in development).

Panel Contracts

Addition of guidelines around the use of panel contracts.

Variations

There are opportunities to clarify expectations and improve our processes involving contract variations. This will improve both contract performance and financial management.

It is recommended that variations be approved based on the cumulative value of the contract, rather than the value of the variation. This change will provide greater transparency and oversight to the Senior and Executive Leadership Teams on contract activity.

Changes to instruments of delegations are also being recommended to support these changes.

Thresholds

The separate requirements for works and goods/services is confusing, particularly for those staff that procure both. This causes errors to be made and creates a surplus of templates and procedures.

It is recommended the policy be changed to one combined set of thresholds for all procurement to reduce confusion and drive compliance.

CEO Instrument of Delegation

To support the changes to the Policy, changes to the Instrument of Delegation from Council to the Chief Executive Officer (CEO) are also being recommended. By increasing delegations, officers will be able to receive endorsement on projects quicker, secure pricing, improve efficiency, manage contract variations promptly and reduce risk.

The recommended change will provide a clear line of escalation by including an escalation point between the administration and Council, and consistency in the assessment of variations whether initially awarded under delegation or by Council.

The changes proposed are as follows:

- Increase the CEO's delegation to \$1 million for contract awards
- Authorise contract variations for contract awards under delegation up to a maximum cumulative contract total of \$1,100,000 (10% above CEO's delegation)
- Authorisation for contract variations to Council awarded contracts remains at a maximum of 10% of the awarded contract sum, unless otherwise authorised by Council resolution.

Subject to Council approval of the Policy, officers will make the required changes to the Instrument of Delegation from Council to the CEO.

7.8 Proposed discontinuance and sale of road reserve - Adjoining 41 McShane Street, Balwyn North

Purpose

This report is to consider commencement of the statutory procedures to discontinue, take title and sell the 3.05m wide section of road reserve, with a land area of 44.5 m² at the front of 41 McShane Street, Balwyn North.

Background

Council received a request from the owner of 41 McShane Street, Balwyn North, for the discontinuance and sale of the above unconstructed section of road reserve at the front of the property, as shown hatched on **Attachment 1**.

Key Issues

- The Road is in the name of the original subdivider.
- The Road Reserve is considered by officers to be of little practical value to Council.
- The Road Reserve has been enclosed within the front yard of 41 McShane Street, Balwyn North, for in excess of 15 years.
- The discontinuance and sale of the Road requires Council to comply with section 206 clause 3 of Schedule 10 of the *Local Government Act 1989* and section 114 of the *Local Government Act 2020*.

Confidentiality

Confidential information is contained in **Confidential Attachment 1**, as circulated in the confidential section of the agenda attachments. The information in this attachment is deemed to be confidential in accordance with section 66(2)(a) and the definition of 'confidential information' in section 3(1) of the *Local Government Act 2020*. The information is Council business information which would prejudice the Council's position in commercial negotiations if prematurely released.

If discussion of the confidential information in the attachments to this report is required for Council to make a decision, Council may resolve to discuss the matter in a confidential session or to defer the matter to the confidential section of the agenda.

- 6. Authorise the Chief Executive Officer, or such other officer as the Chief Executive Officer approves, to sign all necessary documentation for the sale of the land to the owner of the adjoining property at 41 McShane Street, Balwyn North, for the sum of \$27,925.00 (inclusive of GST), in accordance with Principle 3 of Council's Discontinuance of Roads and Reserves Policy.

- Tomorrow night, on Tuesday 23rd April 2024 at 6:30pm there is an event at Hawthorn Arts Centre which features distinguished local artist George Patre OAM discussing his book 'The Art of Sacrifice'. This book features 60 to 70 portraits and 63 stories and historical images which tell the stories of ANZAC's their courage, their sacrifice. This event is a collaboration between our arts and libraries teams.
- I would also like to acknowledge the brave men and women from the Kew Memorial who the Rotary Club of Kew have begun to digitise and created a 'Kew remembers' website.
