

7.2 Boroondara Triennial Operational Grant Allocations 2020-23

Abstract

This report contains the recommendations of the Community Strengthening Grants Assessment Panel for the allocation of the 2020-23 Boroondara Triennial Operational Grants in four streams: Healthy Community, Sustainable Community, Creative Community and Vibrant Retail Precincts.

The Boroondara Triennial Operational Grants support the long-term development of programs and services that address key priorities for Council in meeting the needs of the community. The grants cover operating and program costs associated with the delivery of services, and celebrations and events in the City of Boroondara.

In December 2019, Council adopted the Boroondara Community Strengthening Grants Policy 2019 (the Policy) to align the current grant categories and streams contained in the Policy with the relevant themes and strategies in the Boroondara Community Plan 2017-27 (the BCP). As a result of the Policy review, a new stream, Vibrant Retail Precincts was introduced to the Triennial Operational Grants, Annual Community Strengthening Grant and the new Small Grants (Biannual) categories. The Vibrant Retail Precincts stream focuses on projects and activities that activate local shopping centres and other public spaces, such as trader festivals, which is also aligned with Council's placemaking initiative and the Economic Development and Tourism Strategy 2016-2021.

A further amendment of the Policy was the removal of the Registered Rooming House Subsidy (RRHS) from the Community Strengthening Grants Policy, and the annual funding for this program reassigned to the Triennial Operational Grants in the Healthy Community stream. Eligible organisations, including those working in partnership with registered rooming house operators, are encouraged to apply for the reassigned funding to deliver services to people who are experiencing primary or secondary homelessness (sleeping rough or residing in rooming house accommodation) with the intention of connecting them with support services.

The funding pool for Triennial Operational Grants is \$455,178 annually. No contribution is received from the Rotary Club of Balwyn, which provides a contribution towards the Annual Community Strengthening Grants.

This year, the panel has recommended full or partial funding for 42 of the 44 applications. Within the Healthy and Sustainable Community stream, the Panel recommended full for 10 of the 11 applications, partial funding for 25 of the 26 applications in the Creative Community stream and partial funding for all seven applications in the Vibrant Retail Precincts stream. Partial funding was allocated to enable as many projects to be funded as possible, as demand exceeded the available funding in the Creative Community and Vibrant Retail Precincts streams.

In the Healthy and Sustainable streams the funding pool is \$551,220 over three years (\$183,740 annually) and includes funds rolled over from the Registered Rooming House Subsidy allocation. The amount allocated by the panel in the Healthy Community stream is \$138,387, leaving unexpended funds of \$45,353 in 20-21. Since the panel met, an application has been approved under the 19-20 RRHS allocation, which is an operational grant administered by officers, and the remaining funds are \$40,353 in 20-21.

The Creative Community stream has a funding pool of \$405,000 over three years and is divided into two categories, Creative and Cultural Groups and Creative Community Events and is fully expended.

The Vibrant Retail Precincts stream has a funding pool of \$409,314 over three years and is fully expended.

The funding available in all streams is adjusted annually by CPI.

The total amount requested over three years is \$2,186,502 and the amount allocated is \$1,229,475, which is the total funding pool in the 20-23 round.

3. Rollover unexpended funds of \$45,353 to the Annual Community Strengthening Grants in 21-22 and 22-23.

1. Purpose

This report seeks Council endorsement of the recommendations of the Community Strengthening Grants Assessment Panel for the 2020-23 Boroondara Triennial Operational Grant allocations.

2. Policy implications and relevance to community plan and council plan

Boroondara Community Plan 2017-27

The Boroondara Community Plan 2017-27 is Council's key strategic document and it describes the community's 10-year vision and priorities. It guides Council's decision making, and directly informs the Council Plan, budget processes, and Council strategies, plans, policies and actions.

The Boroondara Community Plan is structured around seven themes our community told us were important to them and each includes a strategic objective describing the outcomes we are seeking to achieve. The three strategies of relevance for this report are:

Strategy 1.3 under the Priority Theme of Your Community, Services and Facilities.

Deliver, facilitate and advocate for services and programs that promote health, wellbeing, safety and a sense of community.

Strategy 1.8 under the Priority Theme of Your Community, Services and Facilities.

Facilitate and produce diverse arts and cultural programs to provide entertainment and increase participation in community life for residents and tourists.

Strategy 3.1 under the Priority Theme of Your Environment.

Build community capacity to live sustainably through efficient use of energy and water, resource recovery and renewable energy generation.

Strategy 6.3 under the Priority Theme of Your Local Shops and Businesses

Showcase and promote the City's attractions to increase visitation and spending locally.

Council Plan

The Boroondara Council Plan 2017-21 vision is a vibrant and inclusive city, meeting the needs and aspirations of its community. The three relevant themes for this report are:

- Priority Theme One: Your Community, Services and Facilities.
- Priority Theme Two: Your Environment
- Priority Theme Six: Your local Shops and Businesses

Council policies, plans and strategies

The Boroondara Community Strengthening Grants Policy 2019, sets out the parameters for the allocation of the 2020-23 Boroondara Triennial Operational Grants. It integrates Council's grant funding activities so they strategically align to community needs, as identified within the Council Plan 2017-21.

The allocations recommended by the Community Strengthening Grants Assessment Panel also support commitments contained in the Boroondara Arts Plan, the Multicultural Action Plan 2019-23, Disability Action Plan 2018-22, Add life to your years - Healthy Ageing in Boroondara Plan, the Integrated Water Management Strategy 2014-24, the Urban Biodiversity Strategy 2013-23 and the Waste Minimisation and Recycling Strategy.

3. Background

The Boroondara Triennial Operational Grants support the long-term development of programs and services that address key priorities for Council in meeting the needs of the community. The grants cover operating (including salary) and program costs associated with the delivery of services, and celebrations and events in the City of Boroondara.

In December 2019, Council adopted the Boroondara Community Strengthening Grants Policy 2019 (the Policy) to align the current grant categories and streams contained in the Policy with the relevant themes and strategies in the Boroondara Community Plan 2017-27 (the BCP). As a result of the Policy review, a new stream, Vibrant Retail Precincts, was introduced to the Triennial Operational Grants, Annual Community Strengthening Grants and the new Small Grants (Biannual) categories. The Vibrant Retail Precincts stream focuses on projects and activities that activate local shopping centres and other public spaces, such as trader festivals, which is also aligned with Council's placemaking initiative and the Economic Development and Tourism Strategy 2016-2021. Trader festivals have been reassigned to this stream having previously sat under the Creative Community stream.

A further amendment of the Policy was the removal of the Registered Rooming House Subsidy (RRHS) from the Community Strengthening Grants Policy, and the annual funding for this program reassigned to the Triennial Operational Grants in the Healthy Community stream. Eligible organisations, including those working in partnership with registered rooming house operators, are encouraged to apply for the reassigned funding to deliver services to people who are experiencing primary or secondary homelessness (sleeping rough or residing in rooming house accommodation) with the intention of connecting them with support services.

The four streams in the Triennial Operational Grants are:

- Healthy Community
- Sustainable Community
- Creative Community
- Vibrant Retail Precincts.

All applications were initially assessed by Council officers on the basis of the assessment criteria provided in the grant guidelines. Assessments were made using a rating scale from 0 to 10 with scores assigned to one of the following four categories:

- Highly Recommended Overall (81% - 100%)
- Good Overall (66% - 80%)
- Fair Only (50% - 65%)
- Not Recommended Overall (under 50%).

All applications recommended for funding achieved a rating of 'Good Overall' or above. The officer assessments, along with officer understanding of the community outcomes the project would have, were reviewed by the relevant managers. A number of organisations that applied for a 2020-23 Triennial Grant were also funded in the 2017-20 round. Officers provided information on the community outcome of each organisation's current grant, what the benefits of continuing the programs would be, and whether the community would be disadvantaged if these existing services ceased.

The Panel considered this advice and the ratings in its deliberations. The Panel also based its decisions on the application of the program guidelines, and an analysis of the financial investment against the potential community benefit from the service/activity.

Due to COVID-19 social distancing restrictions, the Community Strengthening Grants Assessment Panel meetings were held via Webex and there were four Councillor representatives (Councillors Ross, Sinfield, Watson and Wegman). Three officers from the Community Planning and Development Department provided executive support to the panel. Relevant department managers and officers also attended the meetings to provide additional advice to the panel. A full list of attendees is listed in **Confidential Attachment 2**.

4. Outline of key issues/options

There were 44 applications for the 2020-23 Triennial Operational Grants, seven less than 2016, with 15 new applicants. The Healthy Community and Sustainable Community streams received 11 applications of which three were new, the Creative Community stream received 26 applications and 12 were new to this stream, and the new Vibrant Retail Precincts stream received seven applications of which two were new. One application in the Healthy Community stream was ineligible because it did not meet the eligibility criteria.

Applicants were asked to address the impact of the current COVID crisis on proposed programs and activities. All are able to adapt their programs, reformat or hold events at a later time.

The funding pool for Triennial Operational Grants is \$455,178 annually, which includes rolled over funds from the RRHS in the Healthy Community stream. No contribution is received from the Rotary Club of Balwyn, which provides a contribution towards the Annual Community Strengthening Grants. The table below shows the community demand for funding compared with the funding allocated, as well as the funding available in each stream. All figures in the table below have been calculated per annum due to the Council budget being endorsed annually.

This year, the panel has recommended full or partial funding for 42 of the 44 applications as listed in **Attachment 1**. Within the Healthy Community and Sustainable Community stream, the Panel recommended full funding for 10 of the 11 applications in the streams, partial funding for 25 of the 26 applications in the Creative Community stream and partial funding for all seven applications in the Vibrant Retail Precincts stream.

From the available funding of \$455,178, the amount allocated is \$409,825, with \$45,353 unexpended from the Healthy Community stream. As this stream included funds rolled over from the RRHS, Council officers worked with relevant community groups and organisations to develop applications for programs working with people who are experiencing primary or secondary homelessness. Unfortunately none of these groups submitted an application.

Since the panel met, an application has been approved under the 19-20 RRHS allocation, which is an operational grant administered by officers, and the remaining funds are \$40,353.

The Community Strengthening Grants Assessment Panel made recommendations to award two applications in the Healthy Community stream more than the amount requested. As per the 2020-23 Triennial Operational Grants Guidelines, 'the Grants Assessment Panel is able to make recommendations to Council that may be outside the guidelines if it believes important community outcomes can be achieved.' These applications are listed in **Attachment 1**.

The applications recommended for funding will have a positive social impact within the Boroondara community. They will support low-income residents and residents who are marginalised by disability or mental ill-health. The grants will also build connected and inclusive communities, strengthen community wellbeing, environmental awareness, cultural innovation and artistic practice and deliver services, celebrations and events initiated by local retail traders.

Applications not recommended for funding and ineligible application are listed in **Confidential Attachment 3**.

As a result of the cessation of the Camberwell Sunday Market on Sunday 22 March 2020 due to COVID-19 restrictions, the Rotary Club of Balwyn's contribution to the 2020 Annual Community Strengthening Grants will be less. It is a condition of the lease for the Camberwell Sunday Market that 30% of the market income is allocated to the Annual Community Strengthening Grants. The Community Strengthening Grants Assessment Panel has therefore recommended the unexpended funds be rolled over to the Annual Community Strengthening Grants. As the allocation of the Triennial Operational Grants is for period 20-23, the rollover of the unexpended funds to the Annual Community Strengthening Grants will be \$40,353 in 20-21 and \$45,353 21-22 and 22-23.

5. Consultation/communication

The Triennial Operational Grants program was promoted widely through the *Progress Leader*, the *Boroondara Bulletin*, *The Fuse* e-newsletter, Council's social media and the City of Boroondara website from 2 January to 24 February 2020, which included a step-by-step guide to assist community groups and organisations in submitting an application.

6. Financial and resource implications

As noted earlier, the total funding pool for the 2020-23 Triennial Operational Grants was \$455,178. This year \$409,825 of the total pool has been allocated. The Panel recommended the remaining grant funds be transferred to the Annual Community Strengthening Grants, which will be \$40,353 in 20-21 and \$45,353 in 21-22 and 22-23, due to the once-off grant allocated after the panel met.

7. Governance issues

The implications of this report have been assessed in accordance with the requirements of the Victorian Charter of Human Rights and Responsibilities. The Panel met over two evenings, 4 and 6 May 2020.

Cr. Felicity Sinfield declared a Conflict of Duty with Boroondara Stroke Support Group. Cr Sinfield left the meeting and did not participate while the Assessment Panel reviewed this application.

Conflict of interest declarations for all Panel members and officers are listed in **Attachment 1**.

8. Social and environmental issues

The 42 applications recommended for funding will have a positive social impact within the Boroondara community. They will support low-income residents and residents who are marginalised by disability or mental ill-health. The grants will also build connected and inclusive communities and strengthen community wellbeing, environmental awareness, cultural innovation and artistic practice and deliver services, celebrations and events initiated by local retail traders.

Triennial Operational funding provides organisations with the financial certainty they need to undertake longer term planning and attract other resources. It also improves their capacity to plan and deliver community, environmental and, celebrations, events and cultural services, and to build partnerships with other organisations that strengthen the social infrastructure in Boroondara.

9. Evaluation and review

The outcomes from the 42 applications recommended for funding will have a positive social and environmental impact within the Boroondara community and demonstrate a number of trends and community needs.

Feedback from Panel members, Council officers and applicant organisations will also inform all aspects of future planning for this Triennial Operational Grants category.
