- 3.1 Contract 2020/153 Supply and Delivery of Horticultural Chemicals and Fertilisers

This report seeks Council endorsement for the award of Contract No. 2020/153, Supply and Delivery of Horticultural Chemicals and Fertilisers. This contract will provide Council with a supply of horticultural chemicals and fertilisers to assist with the preservation of the open spaces located throughout the municipality, for an initial term of four (4) years with two (2) possible extensions of three (3) years each, for a maximum contract term of ten (10) years.

This is a replacement of an existing contract which has reached the end of its maximum term.

The estimated cost of this Contract for a ten year maximum contract term is \$1,967,800 (excluding GST). Expenditure in future years will be in accordance with approved budget allocations. The contract was publicly advertised in accordance with the requirements of section 186 of the *Local Government Act.1989*.
