2. Election of the Mayor for 2022-2023

The election of the Mayor of the City of Boroondara is conducted annually.

Following the election of the Mayor, the Mayor is welcomed to the position as Leader of the City, and first Citizen.

The Chief Executive Officer, Phillip Storer, invited nominations for the office of the Mayor for the 2022-23 Mayoral year.

Councillor Hollingsworth nominated Councillor Sinfield. Councillor Parke seconded the nomination. Councillor Sinfield accepted the nomination.

Councillor Gillies nominated Councillor Addis. Councillor Gault seconded the nomination. Councillor Addis accepted the nomination.

The Chief Executive Officer then invited Councillors to vote for their preferred Candidate.

Councillor Sinfield received a total of six votes.

Councillor Addis received a total of five votes.

Having received an absolute majority of votes, the Chief Executive Officer declared Councillor Sinfield elected to the position of Mayor of Boroondara City Council for 2022/23.

The Mayor, Councillor Sinfield, assumed the Chair at 8.36pm.

- The Mayor is incapable of performing the duties of the office of Mayor for any reason, including illness; or
- The office of the Mayor is vacant.

The Mayor invited nominations for the office of the Deputy Mayor for 2022-23.

Councillor Gault nominated Councillor Gillies. Councillor Addis seconded the nomination. Councillor Gillies accepted the nomination.

Councillor Parke nominated Councillor Hollingsworth. Councillor Watson seconded the nomination. Councillor Hollingsworth accepted the nomination.

The Mayor then invited Councillors to vote for their preferred Candidate.

Councillor Gillies received a total of five votes. Councillor Hollingsworth received a total of six votes.

Having received an absolute majority of votes, the Mayor declared Councillor Hollingsworth elected to the position of Deputy Mayor of Boroondara City Council for 2022/23.

4. Election of Chairpersons to Delegated Committees of Council

Chairpersons of the Urban Planning Delegated Committee and Services Delegated Committee are elected annually.

The Mayor invited nominations for the Chairperson of the Urban Planning Delegated Committee.

Councillor Addis nominated Councillor Gault. Councillor Biggar seconded the nomination. Councillor Gault accepted the nomination.
