1. Definitions

Boroondara Literary Awards Ceremony means the invite-only award ceremony of that name which is to be held on or about Thursday 12 September 2024 at a location to be determined in the Promoter's absolute discretion.

Competition means the competition, including each category and sub-category, as specified in Item 2.

Draw Detail means the details specified in Item 5.

Entrant means any person who enters or purports to enter the Competition.

Entry means an original literary work created by an Entrant and submitted into the Competition.

Entry Period means the period specified in Item 3.

Entry Procedure means the procedure specified in Item 4.

Immediate Family Member means a person's spouse, ex-spouse, de facto spouse, parent or stepparent, child or step-child (whether natural or by adoption), grandparent or step-grandparent, sibling or step-sibling, first cousin, uncle, aunt, niece or nephew.

Item means an item in the Schedule of these Terms.

Prize means the prize specified in Item 7.

Promoter means Boroondara City Council as specified in Item 1.

Schedule means the schedule at the start of these Terms.

Special Conditions means the special conditions in Item 8.

Terms and Conditions means these terms and conditions as amended from time to time.

Winner means an eligible Entrant selected by the judge(s) from the Competition to receive the Prize.

Winner Notification means the procedure specified in Item 6.

2. Acceptance of Terms and Conditions

By entering this Competition, you, as the Entrant acknowledge and agree that:

- 2.1. Information on how to enter and the conditions of entry form part of these Terms and Conditions;
- 2.2. Participation in the Competition is deemed acceptance of the Terms and Conditions;
- 2.3. All Items may be subject to further conditions contained in attached clauses;
- 2.4. All costs associated with entering the Competition remain the responsibility of each Entrant;
- 2.5. All details provided by the Entrant are true and accurate.

3. Eligibility

3.1. **Open Short Story Competition**

(a) Entry to the Open Short Story Competition is open to all Victorian residents.

3.2. Young Writers Competition

(a) Junior Category

The Junior Category is only open to Entrants enrolled in primary school years 5 and 6, who live or study in Boroondara.

(b) Middle Category

The Middle Category is only open to Entrants enrolled in secondary school years 7, 8 and 9, who live, work or study in Boroondara.

(c) Senior Category

The Senior Category is only open to those Entrants enrolled in secondary school years 10, 11 and 12 or those Entrants aged fifteen (15) to eighteen (18) years old as at 1 January 2024, who live, work or study in Boroondara.

3.3. General

- (a) Employees of the Promoter or the Rotary Club of Balwyn and Immediate Family Members of employees of the Promoter or the Rotary Club of Balwyn are ineligible to enter the competition.
- (b) Entrants under the age of eighteen (18) years old must provide parental or guardian consent to enter the Competition. If Entrants under the age of eighteen (18) do not obtain such consent, their Entry will be deemed invalid.

4. How to Enter

- 4.1. To enter the Competition, the Entrant must follow the Entry Procedure specified in Item 4 to the extent that Item 4 is not inconsistent with these Terms and Conditions.
- 4.2. Entries will be deemed invalid if submitted outside of the Entry Period specified in Item 3.
- 4.3. Entrants must elect to enter either:
 - (a) the Open Short Story Competition; or
 - (b) the Young Writers Competition.

4.4. **Open Short Story Competition**

(a) If the Entrant enters the Open Short Story Competition, the Entrant is only permitted to submit one Entry.

4.5. Young Writers Competition

- (a) If the Entrant enters the Young Writers Competition, the Entrant may submit up to:
 - (i) One Entry into the Prose sub-category; and
 - (ii) One Entry into the Poetry sub-Category.

5. Draw Details

- 5.1. The Promoter will select the Winner(s) following the procedure specified in Item 5.
- 5.2. The Promoter reserves the right to select reserves in case of an invalid Entry or ineligible Entrant.
- 5.3. Where applicable, a judge or judges will be appointed by the Promoter at its absolute discretion. The judge or judges' decision is final and binding on Entrants.

6. Winner(s) Notification

- 6.1. The Winner(s) will be notified by the procedure in Item 6.
- 6.2. The names of the Winner(s) will be published on Boroondara City Council website.
- 6.3. While best efforts will be made to contact Winners, a Winner will forfeit the Prize in whole, and another Entrant will be selected by the judge(s) to win the Prize, if:
 - (a) The Winner fails to respond within five days of the Winners Notification; or
 - (b) The Winner cannot be reasonably identified or notified and reasonable efforts made by the Promoter to identify and notify the Winner were unsuccessful.
- 6.4. Winners of any subsequent selection will be notified via the procedure specified in Item 4 within five days of the subsequent selection.

7. Prize

- 7.1. The Prize is specified in Item 7 and is to be paid via Electronic Funds Transfer.
- 7.2. The Prize value is the recommended retail value in Australian dollars and is correct at time of printing. The Promoter takes no responsibility for variations in the Prize value.
- 7.3. The Prize is not exchangeable or redeemable for cash or other prizes. The Prize is provided by the Promoter. Transport, parking and any other costs associated with redeeming the Prize are at the Winner(s)' expense.

- 8.2. The Entrant acknowledges that any personal information collected may also be used to update Council's customer databases to assist the Promoter in discharging its functions or providing services.
- 8.3. The Entrant acknowledges that some personal information collected may also be used and disclosed in the Promoter's marketing promotions and retail activities, or when exhibiting or publishing submitted entries and such use and disclosure may occur outside Victoria.
- 8.4. Any personal information collected will not otherwise be disclosed unless permitted or required by law.
- 8.5. The Entrant acknowledges that if the personal information is not collected, the Entrant's Entry may be invalid.

- 8.7. The Entrant acknowledges and accepts that any Entry submitted to the Competition will be:
 - (a) collected and stored by the Promoter for the purposes of Council publications and use on the Council website or for other marketing purposes; and

9. Release and Indemnity

9.1. To the extent permitted by law, all Entrants release from, and indemnify the Promoter against all liability, cost, loss, or expense arising out of acceptance of any prize(s) or participation in the Competition including (but not limited to) loss of income, loss of opportunity, personal

injury, and damage to property, whether direct or consequential, foreseeable, due to some negligent act or omission or otherwise.

10. General

- 10.1. All decisions and actions of the Promoter relating to the Competition and/or redemption of the Prize are exercised at its absolute discretion and are final. No discussions or correspondence with Entrants or any other person will be entered into.
